AGREEMENT

This credit Application ("Application") is submitted by Applicant to EAA to obtain trade credit. Applicant understands and agrees that credit extended hereunder shall be used solely for business purposes, and Applicant agrees to pay all accounts to EAA in full on or before 30 days from date of invoice, unless subsequently agreed to in writing. Applicant also agrees to pay late charges and interest on all amounts that are past due at the rate of one and one-half percent (1.5%) per month on the unpaid balance due on the delinquent invoice, all payments to be applied first to interest, then to costs of collection if any, and then to the unpaid principal balance. If Applicant defaults on any payment or on any commitment in this Application, EAA reserves the right to declare all of Applicant's invoice amounts immediately due and payable without notice to Applicant. If EAA ever, in its sole judgment, uses a collection agent or legal counsel, or other means, to obtain collection of an unpaid balance from Applicant or any guarantor, all of EAA's costs of collection, including without limitation any contingent and/or hourly legal fees and legal costs, will be continuously added to such unpaid balance until such unpaid balance is paid in full.

Any agreement by EAA to provide credit to Applicant, based on and wholly or partly in consideration of the information and commitments provided herein by Applicant, shall become effective upon acceptance by EAA, and only to the extent of the credit provided and not with respect to any future request for provision of credit. Applicant agrees to provide EAA with updated credit information (a) on request; and (b) without request upon any change in Applicant's circumstances that a reasonably prudent creditor would want to know about. Applicant agrees, when requested, to provide an annual financial statement to EAA as a condition for the continued extension of credit. This Application is not transferable or assignable.
