1. If you wish to appoint as your proxy a person other than the individuals named in Line A, please check Box B and insert the name of that other person in the space provided. In this case you must initial in the space provided.
2. If you wish to direct your proxy to cast your vote for specific candidates please check Box C and insert an "X" in the relevant "Vote For" boxes. You must initial in the space provided. If you do not wish your proxy to vote for a particular candidate, you may insert an "X" in the relevant "Vote Withheld" box. A "Vote Withheld" will not be counted in the votes "For" a Director. You may also insert the names of other individuals in the blank spaces. If you do not check Box C and indicate how your proxy is to vote, you will be deemed to have authorized your proxy to vote or to withhold your vote as your proxy sees fit.
3. Aside from voting for candidates for Director, your proxy will also be authorized to vote at his/her discretion on any other matter properly put to the member annual meeting to be held on July 22, 2020.
