

NO PURCHASE NECESSARY. The AirVenture Selfie Scavenger Hunt is open to legal residents of the United States and the District of Columbia, 13 years of age or older. Employees of the Experimental Aircraft Association, sister organizations, and their immediate families are not eligible to enter. The AirVenture Selfie Scavenger Hunt entry period starts at 12:00 p.m. CST Sunday, July 19, 2015 and ends on Sunday, July 26, 2015.

ELIGIBILITY. To be eligible for AirVenture Selfie Scavenger Hunt, social posts must be submitted before 11:59 a.m. each day of the contest. All entries must be received during the AirVenture Selfie Scavenger Hunt entry period to be eligible for consideration.
