FAQ and General Food Vendor Information:

- EAA considers a ***Food Vendor*** to be defined as the following:
 - *A restaurant, bar, grocery store, delicatessen, bakery, food service establishment (carry out, quick service, full-service), food truck, itinerant restaurants, pushcart, farmers market, caterer, microenterprise home kitchen operations, cottage food operations, selling Prepared Food to be consumed on and off the premises located or operating on or off property owned/leased/operated by EAA. EAA reserves the right to alter/adjust/amend this definition in the overall best interest of Experimental Aircraft Association, Inc. and EAA Aviation Foundation, Inc.*
- EAA does not keep waiting lists.
- Food Vendors will be chosen on an 'as needed' basis.
- Food Vendors are not chosen based on the order of when we receive their application.
- As stated in the previous paragraph, we do offer our previous year's Food Vendors the right of first refusal.
- Therefore, there may not be openings for new Food Vendors, as we have a finite number of Food Vending locations.
- All ***EAA AirVenture Oshkosh Food Vendors*** are subject to a percentage-based commissions to EAA.
- EAA requires all ***EAA AirVenture Oshkosh Food Vendors*** to utilize, at all times, our POS System. EAA has an exclusivity contract with **Fiserv/Clover – EAA does not allow the use of any other POS services/systems**. There is a fee, of which the Food Vendor pays directly to Fiserv, for the use of their equipment. Additionally, Fiserv/Clover does charge a percentage on all credit card transactions.
- EAA requires all ***EAA AirVenture Oshkosh Food Vendors*** to obtain and maintain occurrence-based insurance policies. All insurance requirements are listed in full in the ***EAA AirVenture Oshkosh Food Vendor Agreement*** and all insurance policies must be provided to EAA Risk Management upon signature of the ***EAA AirVenture Oshkosh Food Vendor Agreement***.
- EAA has an exclusivity contract with **PepsiCo Beverage Sales, LLC, a Delaware limited liability company, and its affiliates and/or respective subsidiaries collectively comprising Pepsi Beverages Company**.
- ***Only*** Pepsi Beverages may be sold, by the ***EAA AirVenture Oshkosh Food Vendor*** during the term of this Agreement. "***Beverages***" means all carbonated and non-carbonated, non-alcoholic drinks, however dispensed during the Term of the Agreement. For purposes of this Agreement, "***Beverages***" shall ***not*** include fresh squeezed lemonade, bulk orange juice, root beer floats, hot coffee, and hot tea.
- The ***EAA AirVenture Oshkosh Food Vendor*** will purchase ***all*** Pepsi Beverages from the on-site ***EAA AirVenture Oshkosh*** Pepsi representative.

- EAA has an exclusivity contract with **Arena Event Services, Inc. d/b/a Arena Americas**. They supply EAA, our food vendors, and our exhibitors with rentable Tents, Tables & Chairs. You do NOT have to rent these items from Arena – you can bring in your own, but you *cannot* have another outside company come onto the grounds to deliver and/or set-up any Tents/Tables/Chairs.
- EAA has an exclusivity contract with **GES – A Global Exhibition and Trade Show Management Company**. They work closely with Arena Event Services, Inc and supply additional rental items.
- EAA has an exclusivity contract with **Mars Wrigley Confectionery US, LLC**. **All items such as chocolates, candies, and novelty ice cream** items sold *must* be from Mars Wrigley Confectionery US, LLC.
- EAA does not charge for the **vendor location, water, nor electricity**.
